

# Animal Release

Many times during the school year, the Agricultural Science Teachers of the Calallen Independent School District are asked to help students in selecting, transporting, treating, fitting, training, and otherwise helping students manage their animals. We are anxious to help the students in anyway that we can; however, accidents can occur. The possibility that an accident may happen increases as the number of animals increase. We have a great deal of exposure along these lines each year. We are requesting that each student and his/her parent or guardian sign this consent form, stating that they will not hold Mrs. Frances Nelson, Mr. Shylar Brooks, or Mr. Bobby Farias liable for any accident that might occur when handling their animal(s).

In securing new animals, the animal belongs to the student when the teacher, as your advisor, takes possession of the animal. Students and parents not wishing to take this risk should consider the possibility of insuring their animals or securing their own animals. We teachers exercise all possible care to prevent all accidents.

In the case of emergency and you feel that it is necessary to remove your animal from the farm due to circumstances such as a hurricane, flood, etc., you are responsible for the removal of your animal. The Agricultural Science teachers are not responsible for taking your animal to safety or feeding your animals if you leave town for evacuation purposes. Please make plans for the feeding and well-being of your animal on your own.

**We do not hold Mrs. Frances Nelson, Mr. Shylar Brooks, or Mr. Bobby Farias responsible or liable for any accidents or injuries to our animal(s) under their supervision.**

## Equipment Release

At times, you may borrow equipment from the Calallen FFA. If a piece of equipment breaks while in your possession you are responsible for repairing or replacing the broken item.
